Drivers for the Action Plan

- Increasing population growth on the Central Coast
- Highest rate of companion animal ownership in NSW
- Competing interests and pressures across Council's open space network
- Council is required to balance these interests and pressures when forming a final recommendation





Quick recap from Dec 2022



- Council resolved to do further work on key issues (Davistown, Terrigal and Time Access) and simplify the Draft Plan
- Expert advice sought
- Consultation report published
- Community workshops held
- Revised Draft Plan produced



Davistown

- Remains a key issue of contention
- Following feedback and further review of key considerations, Council is proposing a revision to the Pippi Point OLA




Proposed off leash area at Wiles Avenue, Wamberal

Next steps




- Recommend further 28-day consultation period

Reclassification of land

22 August 2023



Operational to Community Reclassification

Recommendation to reclassify 80 lots (14 sites in 12 suburbs) to provide greater certainty about long term management

- 4 sites host community facilities (5 lots)
 - at Glenning Valley (part of Berkley Sports Complex), Kanwal (Lakelands Community Centre), Wamberal (Wamberal Memorial Hall) and Yarramalong (St Barnabas Church)
- 9 sites are open spaces or natural areas (75 lots)
 - at Buff Point, Davistown, Hamlyn Terrace, Jilliby, Lisarow, Noraville, Springfield and Watanobbi



Community to Operational Reclassification

Site where resolution to progress to sale is proposed to be revoked:

- Killarney Vale childcare site
- Bateau Bay library site
- Woongarah block of land



Community to Operational Reclassification

Site where confirmation to progress is sought:

- Gosford bowling club
- Wallarah Bay bowling club
- The Greens bowling club
- Wyong recreation club
- Former Norah Head community centre
- Two residential blocks at Yaralla Road, Toukley
- Austin Butler Access, Woy Woy



Community to Operational Reclassification

Site where approval to commence process sought:

- Sporties club, Summerland Point
- Sliver of land at Mann St Gosford
- Two areas required for road reserve:
 - 6W Kemira Road Lake Munmorah
 - Parraweena St Gwandalan





If supported by Council:

- Public exhibition of lots proposed to go from operational to community
- Referral to Local Planning Panel for lots proposed to go from community to operational
