1 Introduction 2.03pm

The chairperson welcomed the group and completed an Acknowledgement of Country.

3 Porters Creek Wetland

2.08pm

Rochelle Lawson (Senior Ecologist) provided a brief update on the Warnervale conservation agreement and protection of Porters Creek Wetland, including the following key points.

 Council resolved to immediately suspend the development of the conservation agreement at the <u>13 April 2021 Ordinary Council Meeting</u> as per below:

That Council authorise the Chief Executive Officer to immediately suspend the development of the Warnervale conservation agreement and any agreement with the NSW biodiversity Conservation Trust to permanently protect the Porters Creek Wetland until the Airport Masterplan, plan of Management and a subdivision plan is registered that subdivides the Wetland and surrounding E2 land from the employment land in Warnervale.

- Staff complied with the resolution and the conservation agreement hasn't progressed.
- Noted the Airport Masterplan and related matters are yet to be finalised and relevant staff were unable to provide updates to this meeting.
- Members have significant concerns about Porters Creek Wetland given the above and request they be updated as things progress.

Action: Updates about Airport Masterplan and related matters to be communicated to members as part of ongoing consultation.

Luke Sulkowski (Unit Manager Environmental Management) noted some members had enquired about a previous Stormwater Harvesting Scheme for Porters Creek. The Scheme is no longer current, and staff are considering new strategies that don't rely on stormwater harvesting. A presentation from Cardno was shared for an overview of the draft Revegetation Plan and Catchment Stormwater Modelling being developed.

4 Update on coastal management

2.57pm

Ben Fullagar (Section Manager Catchments to Coast) and Vanessa McCann provided an update on coastal management including the following key points.

- Phase one consultation for Coastal Management Programs (CMPs) has now concluded and there was a great response to engagement. Updates will continue be provided as available on https://www.yourvoiceourcoast.com/waterways.

Neil Kelleher (Department of Planning, Industry and Environment) noted implications of the cessation of current Coastal Zone Management Programs (CZMPs) as of 31 December 2021, namely the approvals pathways for works and related grant funding. Regarding concerns raised about foreshore developments, there are coastal hazard lines in Development Control Plans which will continue.

Ben Fullagar provided updates on Wamberal Beach Terminal Protection and Sand Nourishment:

- Phase two engagement occurred 29 July and 10 September 2021. Summary report to be provided to Council shortly.

- Noted Council only considered options that were within current capacity given reduced resources.

5 Update on Tuggerah Lakes Expert Panel

3.43pm

Neil Kelleher (Department of Planning, Industry and Environment) provided an update on the Tuggerah Lakes Expert Panel including the following key points.

- Recommendations made by Expert Panel were forwarded to Government bodies. A lot of recommendations are being incorporated into CMPs, however some are not being addressed.
- Outcomes are being reported to Minister and announcement expected soon.
- Expert Panel did some public consultation around August 2021 sessions were well attended.
- Looking to generate a summary report to explain Expert Panel findings so that they may be better understood.
- Neil commended work of Council staff regarding their CMP progress.

6 Update on coastal and catchment operations

3.50pm

James Lawson (Section Manager Environmental Infrastructure) provided an update on coastal and catchment operations including the following key points.

- Council was awarded \$495k NSW Boating Access Dredging Program for The Entrance. Program
 expected to commence early 2022. This may include a berm management plan but yet to be
 determined.
- Wrack and algae program is continuing as usual. Graph shared to show amounts removed on track to meet figures as predicted at last meeting.
- Next lot of collections for Gross Pollutant Traps (GPTs) planned for early 2022. Currently preparing contract details for this work.
- Noted team are busy with strategic sand building works to lift height of North Karagi sand spit to support Little Tern breeding program that flourished last year.

7 Update on flood and stormwater management

3.55pm

Peter Sheath (Section Manager Flood Strategy and Planning) provided an update on flood and stormwater management including the following key points.

- Provided overview of current projects across map of region noting updates are on https://www.yourvoiceourcoast.com/all-projects/floodplain-management.
- Current strategies and plans are here: https://www.centralcoast.nsw.gov.au/council/forms-and-publications/strategies-and-plans
- Staff currently preparing contract for maintenance of stormwater monitoring equipment.
- Construction of GPTs in Wamberal and Gwandalan now finished, as well as upgrades in Blue Haven and Buff Point.

- Project underway for saltmarsh swale in San Remo near the former power plant hot water outlet. Interim investigations have commenced and staff are working with MHL.
- Staff continue to work with Development Assessment teams regarding planning and flooding. Shared preview of updated flood certificates recommendation about floor being above minimal level has been included as per member advice. Members would like to see this better communicated and encouraged, particularly given concerns about sea level rise.
- Regarding question at last meeting about flood mapping for Exempt and Complying SEPP, advice is needed from Strategic Planning about this (noted as part of Action Log).
- Noted there is value in alerting the community to technical assessments used with regard to flooding and planning – good opportunity to leverage local newsletters.

Action: Peter Sheath to provide info on flooding to Ian Carruthers for incorporation into local newsletter.

8 General business 4.39pm

- It was reported that a food processing company was recently fined by the EPA for a pollution event in Ourimbah Creek that occurred in February 2021. Staff were unaware of this and thanked members for flagging.
- Poor water quality in Avoca Lagoon remains a concern. Staff noted there are some current studies underway. Members also noted there are issues with pollution and foreshore works in area still unresolved, that have previously been raised. Staff noted this is being addressed in CMP about working with Local Land Services and landowners.

Action: Ben Fullagar to follow up on planned workshops for Avoca Lagoon and provide update to members.

Members noted concerns about severe bank erosion in Ourimbah Creek. Staff acknowledged
this is an important issue to address and will follow up with relevant stakeholders about a
organising a site inspection.

Action: Staff to organise a site inspection of Ourimbah Creek and follow up with relevant stakeholders about the severe bank erosion. Update to then be provided to members.
