At the Peninsula Leisure Centre (PLC), we strive to provide the best quality care for your child. The PLC's Crèche is a facility provide for children aged six weeks to 12 years.

The Crèche is available for the purpose of providing care to your children while you are using the health and fitness centre, pool, or other recognised PLC activity.

It is important to note that you cannot leave the PLC premises while your child is in the care of the Crèche.

What to Bring

All children's belongings must be clearly labelled. Please ensure your child's nappy is unsoiled before leaving for your activity.

- Prams for babies and toddlers are recommended, as these provide security and a familiar place to sleep.
- Nappies and baby wipes for those children in nappies.
- A change of clothes for all children
- A healthy snack (please see details under Snacks), or a bottle for babies.
- Dummy or comforter.

Signing In and Out

- It is important that your child is signed in and out correctly and that all important information relating to your child is reported to a crèche staff member.
- For children under one year of age, it is requested that you fill in the white board to provide further information about your child. This is to ensure that all children receive high-quality care.

Child Safety and Collection

- For the safety of your child, all children will only be released to the person who signed them in, unless a previous arrangement has been made with the crèche staff.
- To assist us to keep your child safe, it is important that you inform us of any custody and access arrangements.

Prohibited Items

- Nuts
- Popcorn
- Foods that do not comply with our healthy eating policy
- Small, choking hazard items
- Lollies and lollipops
- Toys from home
- Battery-operated items
- Toys that encourage violence such as guns and knives.

Sickness

- For the health and safety of all children and staff who are attending the crèche children cannot attend the crèche when they are sick with a communicable illness.
- Children will be returned to their parent if they become ill during their care at the crèche.

Snacks

Please be advised that the crèche enforces a 'healthy food' policy. See crèche staff for information on foods that can be brought into the crèche. A **NO NUT** policy applies.

Times of High Demand

During busy periods, the crèche can reach its capacity. At these times, there will be a short wait until a place becomes available. The crèche and reception staff thank you for your patience.

Personal Belongings in Children's Bags

- The crèche cannot accept any responsibility for valuables left in children's bags or prams. Children often pull items out of bags, and crèche staff are not responsible for any loss or damage that may occur.
- Electronic items - such as game consoles, phones and iPads - are not permitted, as the PLC is not responsible for any loss or damage to these personal items.
- Lockers are available for items of value. Please ask at Reception for details.
