The Chairperson, Luke Sulkowski, declared the meeting open at 2.00pm

PROCEDURAL ITEMS

1.1 Introduction: Welcome, Acknowledgement of Country, Apologies, Disclosure of Interest

The Chair read an Acknowledgement of Country statement.

Apologies: John Andrews, Deb Holloman, Stephen Atkins – National Parks and Wildlife Service, Alice Howe – Director Environment and Planning, Jamie Barclay – Unit Manager Economic Development and Property,

The Chair acknowledged the recent passing of Audrey Taggart and provided details in relation to Ms Taggart's contribution, involvement in environmental initiatives and membership of the Environment Committee and COSS Task Group of former Gosford City Council, until 2011. Ms Taggart was also a convenor of Katandra Bushcare Group for 15 years, and a life member of the Australian Plant Society.

Larry Melican and Gary Chestnut spoke of the passion and interest in the environment that Audrey had, and her work and contribution.

Resolved

That the Coastal Open Space (COSS) Committee formally acknowledge the passing of Audrey Taggart and her contributions as a former member of local committees, Katandra Bushcare Group and for environmental volunteering.

REPORTS

2.1 Update on the Airport Master Plan

Jamie Barclay, Unit Manager Economic Development and Property, was not available to attend the meeting. Information and a presentation will be provided at a future meeting of the Committee.

Note: The members of the COSS Committee were subsequently invited to a presentation on the Airport Masterplan to the Catchments to Coast on 13 December 2023.

2.2 Update on the Local Environmental Plan

Rod Mergan and Scott Duncan attended the meeting to present to this item, and along with Shannon Turkington, to answer any questions from the Committee.

Committee members acknowledged the next step in the process was for Council staff to consider submissions and present a further report to Council.

In addition, Committee members expressed their appreciation to Council staff involved for their work with the Local Environment Plan process to date.

Resolved

That the COSS Committee notes the information provided in the report.

2.3 Current Fire Trail Upgrade Projects

Phil Foster attended the meeting to present on this item and answer any questions from the Committee.

In response to a question from committee regarding budget for fire trail maintenance, the committee was advised that there was \$500,000 allocated to the works.

In addition, the Rural Fire Service (RFS) has some funding available under their Fire Access and Fire Trail Plan (FAFT). Should Council undertake work on these trails identified in the FAFT plan they may be eligible to apply for RFS grant funds.

It is to be noted that the RFS area covers Central Coast and Lake Macquarie Local Government areas. There was general agreement that more funds will be required in future financial years for fire trail management works.

Luke Sulkowski spoke to recent changes, restructures, and pleasing to see progress being made in this area of work.

Resolved

That the COSS Committee notes the information provided in the report.

2.4 Update on Biodiversity Strategy & Land Acquisition & prioritisation (Standing Agenda Item)

Larry Melican presented on this item and invited any questions from the Committee, detailed below:

- In relation to the Springfield Pond works: Question from the committee regarding if there was any legislation re: controlling a noxious weed, in relation to the responsibilities of the landowner. The Biosecurity Act being adopted / Greater Sydney strategic weed program both identify priorities and actions. Salvinia is identified as a

widespread weed where containment, asset protection, not selling and not importing into NSW are the key strategies. Salvinia does not need to be eradicated. There are provisions in the Biosecurity Act 2015 to issue biosecurity directions.

Noted that, as part of restructure, the Environmental Management Unit is increasing capacity in relation to biosecurity management / weeds officers – new position: Biosecurity (Pest Animal) Officer. The three Biosecurity Officers (2 x Weeds + 1 x pest animal) will work together particularly where there are new incursions of plants or animals that present a potential biosecurity issue.

- Question regarding is there a monitoring process regarding site management plans? Response provided, there is ongoing monitoring , for example bush re-generation, Feedback regarding it not being formalised in the process as outlined in the presentation is acknowledged.

Resolved

That the information on the Central Coast Council Biodiversity Strategy and the land acquisition and prioritisation be noted by the Committee.

2.5 Climate Adaptation Planning for Council's Natural Reserves

Rochelle Lawson attended the meeting to present on this item and answer any questions from the Committee.

In response to queries, this work is an action of the Biodiversity Strategy, the next steps will be consulting with experts in the field and community members, to gather ideas and further the developed framework, for prioritisation and delivery.

It was also noted by Luke Sulkowski in relation to recent restructure – there is an increase staff in the conservation management team, they will support the delivery of the Biodiversity Strategy.

Resolved

That the COSS Advisory Committee notes the information contained in the report.

2.6 Update from Community Representatives (Standing Agenda Item)

Gary Chestnut – presented the report distributed 4 December 2023 on the two COSS trial workshops that were held in November 2023. The report is provided as an attachment to these Minutes.

Information provided, and spoke to the proposed recommendations in the report.

The Chair will consider further these recommendations, including aspects such as rezoning. It is noted the Draft Central Coast Airport Masterplan may have implications on the foot print of the area – both ‘positive’ and ‘negative’ – for example, E4 zone and conservation concerns, and takes the recommendations of the Committee, below.

Comment from a Committee member that expanding the COSS into former Wyong LGA was a long time coming, but a worthwhile exercise.

Resolved

A. Porters Creek Wetland and Warnervale Wetland (also referred to as Warnervale Floodplain R0360) is selected as the preferred site to trial the expansion of COSS into the northern section of the Central Coast Council.

B. In selecting this site:

a. The area of the proposed COSS extension is illustrated on the accompanying map titled ‘Porters Creek and Warnervale Wetland’ consisting of lots (Lot 4 DP 1275094 at 17 Virginia Road, Warnervale; Lot 3 DP 1230740 at 15 Jack Grant Ave, Warnervale; Lot 2 DP 1234942 at 30 Jack Grant Ave, Warnervale; Lot 2 DP 1059616 at 88-98 Alison Road, Wyong)

b. It is noted that the railway line and the proposed Wyong to Warnervale link road that runs parallel to the railway line physically separates the wetland into Porters Creek Wetland and the Warnervale Wetland. Notwithstanding the physical separation the Porters Creek Wetland and the Warnervale Wetland is the same ecological unit.

c. The Porters Creek wetland is restricted and limited to the C2 Environmental Conservation zoned land and does not include any of the E4 General Industrial land associated with the Central Coast Airport or any industrial use.

C. That Council:

a. Rezone the area of land currently zoned C3 Environmental Management on Lot 704/DP 1275094, to C2 Environmental Conservation.

b. Subdivide 15 Jack Grant Ave, Warnervale, 2259 identified as Lot 3 DP 1230740 and 30 Jack Grant Avenue, Warnervale, 2259 identified as Lot 2 DP 1234942 along the zone boundary to separate the Central Coast Airport and industrial land from Porters Creek Wetland.

D. That Council staff:

- a. Bring a report back to the COSS Advisory Committee within 3 months on the implementation of the recommendation.**
- b. Bring a report back to the COSS Advisory Committee within 9 months presenting a preliminary strategy on concepts and engagement of the community for the rehabilitation of the Warnervale Wetland.**

It is noted that a separate Council report will be provided early 2024 as a result of the above recommendation.

2.7 Update from External Representatives (Standing Agenda Item)

Update provided by Daniel Keating, Local Land Services.

Natural Resource Management (NRM) – Assessment Panel meeting was held 20 November 2023. There was allocation of NSW treasury funding, totalling a bit under \$200,000 .

Projects were assessed, however the outcomes are still pending. Further funding allocation are proposed to be announced in the next week or so.

LLS has a new staff member in their Biosecurity team – Luke Mitchell. This will boost their team, which currently is very busy in biosecurity and pest-animal space.

Discussion amongst the Committee regarding Cane Toad and acoustic monitoring which will be occurring at Avoca. No further specific information available, however it is noted there is regular cane toad surveillance in Mandalong and Glenorie.

Fire ants and species are also being monitored.

2.8 General Business

Question in relation to any updates re: Seawall at Wamberal.

Response provided that there are no new updates available – noting this is more a Catchments to Coast Advisory Committee topic under their Terms of Reference.

Title: COSS Advisory recommendation on proposed trial of COSS in the former LGA of Wyong Shire Council

The community members of Council's COSS Advisory Committee met on Friday 1 December 2023, to discuss the selection of a site to recommend to Council for a proposed trial of COSS in the northern section of the Central Coast Council within the former LGA of Wyong Shire Council.

All committee members are aware of the Council Report 2.3 dated 6 June 2023, (copy presented in Attachment A), which resulted in the adoption of the following Action 164 on 18 July 2023:

The Committee be invited to a site inspection of the recently acquired land know as Warnervale Floodplain R0360 (Commonly referred to as the Warnervale Wetland). The members are to also be invited to a separate workshop to identify measures of success and failure of the proposed COSS trial in relation to Report 2.3 tabled at the meeting.

In accordance with Action 164 a site inspection was conducted on Monday 4 September 2023. The Warnervale Wetland outlined in yellow is illustrated in the following aerial photo.

Following the site inspection of 4 September 2023, at the COSS Advisory Committee meeting conducted on 5 September 2023, the committee resolved Action 164:

The Committee be invited to a site inspection of Mount Alison for public recreation opportunities with the same representatives who attended the site inspection at Action 164.

In accordance with Action 164 a site inspection of Mt Alison was conducted on 14 November 2023. The Mt Alison Reserve is illustrated in the following aerial photo.




Fig 3 Mount Alison Reserve

In accordance with the second part of Action 164, COSS members consisting of both staff and community representatives participated in two workshops conducted on 21 and 28 November 2023, to identify measures of success and failure of the proposed COSS trial in relation to Report 2.3.

At the workshops all participants were asked to respond, via the Menti System, to the following questions:

- Q1. *What are the top five outcomes you want to achieve by applying the COSS name to a natural reserve in the former Wyong LGA?*
- Q2. *Identify two key actions required to help achieve each of the five desired outcomes?*
- Q3. *For each of your ten key actions:*
 - a. *Who/which organisation(s) would actively support delivery?*
 - b. *What duration of delivery would be required for effectiveness?*
 - c. *What types of resources are required to implement the actions? Feel free to also estimate quantity.*
- Q4. *For each of the top five desired outcomes:*
 - a. *How would success and failure be measured?*
 - b. *What data would need to be collected to accurately measure success or failure?*
 - c. *What thresholds (e.g. percentage) would determine success/failure?*
 - d. *What resources are required to collect and analyse the appropriate data to assess success/failure?*
- Q5. *Which reserve or reserve groupings is your preferred location for any future COSS trial?*
- Q6. *What are your top reasons for choosing your preferred trial site?*
- Q7. *Do your reasons for nominating your preferred trial site align with your responses to Q1?*
- Q8. *If your preferred site is formally protected with a conservation agreement or similar, would you choose another site for the trial? Please include your reasons for why or why not?*
- Q9. *Can you identify any risks associated with applying the COSS name to a non-COSS reserve(s)?*
- Q10. *Can you identify any risks associated with not applying the COSS name to a non-COSS reserve(s)?*

Based upon the site inspections, subsequent discussions undertaken, along with a review of Council's adopted Biodiversity Strategy, the following recommendation is presented. In presenting the following recommendation the Community members have relied upon:

- 1) Map 1 in Council's Biodiversity Strategy to identify the Council owned land at Porters Creek Wetland.




Fig 4 Council Natural Asset land of Porters Creek Wetland




Fig 6 – Location of 15 Jake Grant Avenue, WARNERVALE identified as Lot 3 DP 1230740




Fig 7 – Location of 30 Jake Grant Avenue, WARNERVALE identified as Lot 2 DP 1234942

In presenting the following recommendations the Community Representatives recognise that:

- The Warnervale Wetland on Lot 704 DP 1275094 is a modified landscape and has only recently been transferred to Council via dedication to allow the development of the adjacent residential release and requires extensive rehabilitation. Although the site is modified, the committee considers it is a significant site for protection and rehabilitation in order to maintain the health and biodiversity values of Porters Creek wetland. This is consistent with a “nature positive” approach as recommended by the Henry Review (Final Report – Independent Review of the Biodiversity conservation Act 2016, August 2023). As a result, the committee recommends its inclusion as part of the COSS in tandem with Porters Creek Wetland.
- We understand that Council has received development contributions for the rehabilitation of wetlands, we respectfully request that all funds collected for this purpose should be directed towards Porters Creek and Warnervale Wetlands.
- Vegetation contained on Lot 2 DP 1234942 contained in the Porters Creek Wetland within the glide path of the approved runway length of 970 metres of the Central Coast Airport will be required to be trimmed.
- To ensure there is a clear delineation between Porters Creek and Central Coast Airport that both Lot 3 of DP 1230740 and Lot 2 of DP 1234942 will need to be subdivided along the zoning boundary of the C2 Environmental Conservation and the E4 General Industrial.

In accordance with the above report the Community Representatives of Council's COSS Advisory Committee presents the following recommendation to Council.

A. *Porters Creek Wetland and Warnervale Wetland (also referred to as Warnervale Floodplain R0360) is selected as the preferred site to trial the expansion of COSS into the northern section of the Central Coast Council.*

B. *In selecting this site:*


- a. *The area of the proposed COSS extension is illustrated on the accompanying map titled 'Porters Creek and Warnervale Wetland' consisting of lots (Council staff to insert lot and DP numbers)***
- b. *It is noted that the railway line and the proposed Wyong to Warnervale link road that runs parallel to the railway line physically separates the wetland into Porters Creek Wetland and the Warnervale Wetland. Notwithstanding the physical separation the Porters Creek Wetland and the Warnervale Wetland is the same ecological unit.***
- c. *The Porters Creek wetland is restricted and limited to the C2 Environmental Conservation zoned land and does not include any of the E4 General Industrial land associated with the Central Coast Airport or any industrial use.***

C. *That Council:*

- a. *Rezone the area of land currently zoned C3 Environmental Management on Lot 704/DP 1275094, to C2 Environmental Conservation.***
- b. *Subdivide 15 Jack Grant Ave, Warnervale, 2259 identified as Lot 3 DP 1230740 and 30 Jack Grant Avenue, Warnervale, 2259 identified as Lot 2 DP 1234942 along the zone boundary to separate the Central Coast Airport and industrial land from Porters Creek Wetland.***

D. *That Council staff:*

- a. *Bring a report back to the COSS Advisory Committee within 3 months on the implementation of the recommendation.***
- b. *Bring a report back to the COSS Advisory Committee within 9 months presenting a preliminary strategy on concepts and engagement of the community for the rehabilitation of the Warnervale Wetland.***

Report purpose

To provide the COSS Committee with an update of the meetings held between Council Officers and Gary Chestnut about the potential to apply the COSS name to a reserve or reserves in the former Wyong LGA on a trial basis.

To request feedback from the COSS Committee on the parameters for assessing the outcomes of the trial, the data required to demonstrate the outcomes of the trial, the thresholds for achievement/non-achievement of each of the parameters, the management actions required to support the trial, the resources required to implement the management actions, the length of time required to assess the effectiveness of the trial and any information relevant to the trial.

Executive Summary

The COSS Committee has discussed the potential to expand the COSS into the former Wyong Local Government Area (LGA) at various times over the past two years. The COSS Committee has been reminded, on these occasions, that bushland reserves and other conservation lands do exist in the former Wyong LGA, they are just not branded as COSS or under any other moniker. On 2 March 2021 the COSS Committee considered Item 9 titled Findings of COSS Report undertaken by the Community Environment Network (CEN).

2.3 Update on proposed trial of COSS in the former Wyong LGA (Action 149) (contd)

In response to Action Item 149 from the COSS Meeting of 13 December 2021, meetings were held with Gary Chestnut as per Action Item 149 on 8 December 2022 and 27 April 2023.

Feedback is sought from the COSS Committee on the parameters for assessing the outcomes of the trial, the data required to demonstrate the outcomes of the trial, the thresholds for achievement/non-achievement of each of the parameters, the management actions required to support the trial, the resources required to implement the management actions, the length of time required to assess the effectiveness of the trial and any information relevant to a potential trial.

Background

The COSS Committee has discussed the potential to expand the COSS at various times over the past two years.

On 2 March 2021, during discussion on Item 9 titled Findings of COSS Report, Jackie Pearson from the CEN provided the COSS Committee with a presentation on the report titled "Strengths, Weaknesses, Challenges and Opportunities of the Coastal Open Space System (COSS)" which had the following objectives:

- To explore the strengths, weaknesses, challenges and opportunities of the COSS
- To present a recommendation on the possibility of expanding the COSS into the former Wyong local government area.
- To present a recommendation on establishment of a Regional Park for the existing COSS.

The relevant action arising following the presentation was:

Action 127: Gary Chestnut to liaise with Luke Sulkowski to clarify the points of difference in the COSS report compared to the Biodiversity Strategy.

Action Item 127 of 2 March 2021 was updated on 9 June 2021 to reflect the actions taken:

A meeting was held, and the differences of interpretation were acknowledged. It was noted that the COSS report and Biodiversity Strategy were drafted concurrently. Gary gave an undertaking that he would review the recommendations in the COSS report with actions that are in the Biodiversity Strategy. Gary to present a combined report on Council's Biodiversity Strategy and future recommendations from the COSS report.

As part of the Action Log update in Agenda Item 1 at the COSS Meeting of 21 September 2021 a new action (no. 136) was recorded in the minutes. Action item 127 was marked as complete.

2.3 Update on proposed trial of COSS in the former Wyong LGA (Action 149) (contd)

Action 136: The Comparison undertaken by CEN of the COSS Report and Council's Biodiversity Strategy to be circulated to Committee Members. Unit Manager Environmental Management to investigate the option of an Extraordinary Meeting to discuss the report.

On 13 December 2021 the COSS Committee considered Item 8 titled 'Comparison between CEN COSS Report and Central Coast Council Biodiversity Strategy'. A decision was made to discuss the item at the ordinary meeting on 13 December 2021 rather than hold an extraordinary meeting for the item. Action 136 was marked as complete in the Action Log, with a new action (149) being recorded:

Action 149: Staff to arrange a further meeting with Gary Chestnut with a view to identifying some existing natural assets and other conservation reserves in the former Wyong LGA that may be considered for trial under the COSS branding and to identify likely tasks required in order to proceed with such a project.

This report is prepared in response to Action Item 149.

Current Status

In response to Action Item 149 from the COSS Meeting of 13 December 2021 meetings were held with Gary Chestnut as per Action Item 149 on 8 December 2022 and 27 April 2023. The Council representatives at the two meetings were Luke Sulkowski, Unit Manager, Environmental Management Unit, Larry Melican, Section Manager Natural Assets and Biodiversity and Rochelle Lawson, Senior Ecologist.

Report

The two meetings held on 8 December 2022 and 27 April 2023 were open and constructive. The following summarises the points of discussion covered:

Key advantages of COSS brand

- The COSS brand offers a level of political or reputation protection, rather than legislative protection.
- The use of the COSS brand may be a simpler way for the community to understand and talk about environmental protection, rather than having detailed knowledge of environmental legislation and ecology.
- The former Gosford City Council received government grants to purchase land. Political kudos resulted from federal government grants, which were especially able to be applied for or lobbied for because of the named system.

2.3 Update on proposed trial of COSS in the former Wyong LGA (Action 149) (contd)

Potential risks associated with applying the COSS brand to other reserves

- The COSS brand does not provide legislative protection for the land, nor a legally binding commitment to manage the land for biodiversity. Community classification of land provides a level of legislative protection under the Local Government Act.
- The COSS branding may not be quite as familiar and well embraced in the north of the LGA. The pilot or broader reserve branding could change that, but the benefits would need to be better understood first.
- Stronger legislative protection of environmentally important land is available under the Biodiversity Conservation Act through establishing Biodiversity Stewardship Agreements or Conservation Agreements. Biodiversity Stewardship Agreements provide an in-perpetuity source of funds for management and include a legally binding commitment to manage the land for its biodiversity values.
- The name itself may present potential disadvantages as not all of the land is coastal, and it is not actually open space (in the sense of open parklands, or having the primary purpose of recreation), but is primarily intended to support native vegetation, biodiversity and habitats.
- If we want to draw attention to bushland reserves, the brand could be applied to areas with established recreational opportunities (e.g. formalised walking trails or lookout opportunities). This would potentially allow for promotion of the environment and compatible nature-based recreation. There are risks in advertising the location of environmental land which have no recreational infrastructure and are held almost exclusively for conservation purposes.
- Naming a reserve COSS may increase expectations that the site will be more intensively managed.

Strategic documents that refer to expansion of the COSS

- Community Strategic Plan - Objective F2: Promote greening and ensure the wellbeing of communities through the protection of local bushland, urban trees, tree canopies and expansion of the COSS.
- Central Coast Regional Plan 2041
 - Strategy 6.3: Local strategic planning should consider opportunities to strengthen the Coastal Open Space System by expanding its links and extending new corridors to balance growth in the north of the region and protect the network of natural areas across the region.

2.3 Update on proposed trial of COSS in the former Wyong LGA (Action 149) (contd)

- Planning Priority 4: Protect vegetated ridgelines and enhance the enjoyment of conservation areas for passive recreation activities compatible with the natural environment
 - Council can strengthen connections between the natural areas of the COSS and lesser vegetated areas within the urban environment by implementing the Central Coast Greener Places Strategy, including planting trees on private land or around schools, health facilities, parks and golf courses.
- Central Lakes Precinct
 - Planning Priority 4: Enhance the blue and green grid
 - Expanding the Central Coast's COSS into the Central Lakes District will secure biodiversity corridors and high environmental value areas to maintain viability.
 - Any development in new growth areas will need to maintain the integrity of the biodiversity corridors and not compromise the movement of wildlife between the mountains and the ocean. This will reinforce the landscape and visual setting for urban development.

Planning Priority 4 for the Central Lakes Precinct is about reserving high environmental value land for the on-going viability of biodiversity in the precinct, rather than applying the COSS name to existing natural reserves.

Expanding the COSS within the existing footprint in the former Gosford LGA

The COSS could be expanded by acquiring identified proposed COSS properties and by reviewing the existing COSS boundary to include properties that support native vegetation which have not been identified on the proposed COSS site list. Council staff are aware of a number of private properties that support bushland in the former Gosford LGA that are not identified for future voluntary acquisition and may have values consistent with the COSS.

Potential Trial location for COSS in the former Wyong LGA

- The transfer of 94.48 hectares of land in 'Precinct 7A' land at Warnervale to Council occurred on 21 October 2022 and was reported to the COSS Committee on 6 December 2022 (see Attachment 1).
- The COSS criteria would need to be applied to proposed reserve(s) for consistency, and the reserves would need to achieve a sufficiently high score that exceeds the 'cut off', which was the process used in the review of the COSS during 2006.

What are the potential indicators of success of a trial in the former Wyong LGA?

The following indicators were put forward for consideration (on the basis that we can demonstrate behavioural and other change resulting from the proposed 'COSS' branding)

2.3 Update on proposed trial of COSS in the former Wyong LGA (Action 149) (contd)

- Increased community understanding and value of the local natural environment?
- Increased community understanding of the threats to biodiversity and the actions that individuals and groups can take to reduce the threats?
- Active community engagement in environmental volunteering?
- A reduction and reversals of encroachments from neighbouring properties into public areas managed for nature conservation?
- A reduction in unauthorised activities on land managed for nature conservation – vegetation lopping/removal, firewood collection, bush rock collection, reptile and other animal poaching, track construction etc.?
- Increased populations numbers of key animal, plant and/or other populations of biota?
- Increased use of the land by the community for activities consistent with biodiversity conservation?

What data needs to be collected to determine the success of the trial?

- This very much depends on what the defined indicator(s) of success are.
- How long would data need to be collected for to be able to provide an evidence-based understanding of trends with biodiversity, as well as community and Council behaviours and activities?
- What resources are required to collect the required data?
- How do we ensure and preserve data integrity in regard to the trial (i.e. to produce an objective results to guide further direction)

Management actions to support the trial

- Budgets and staff time are both already limited, and a trial of applying the COSS name to other reserve(s) and the associated actions, which may include promotional activities, of the site require staff and budget resources.
- Management actions applied to the trial reserve would need to be consistent with those of similar COSS reserves.

Consultation

Meetings were held with Gary Chestnut as per Action Item 149 on 8 December 2022 and 27 April 2023. The Council representatives at the two meetings were Luke Sulkowski, Unit Manager, Environmental Management Unit, Larry Melican, Section Manager Natural Assets and Biodiversity and Rochelle Lawson, Senior Ecologist.

Feedback is sought from the COSS Committee on the parameters for assessing the outcomes of the trial, the data required to demonstrate the outcomes of the trial, the thresholds for achievement/non-achievement of each of the parameters, the management actions required to support the trial, the resources required to implement the management actions, the length of time required to assess the effectiveness of the trial and any information relevant to a potential trial.

The recommendations of the report do not have a financial impact on Council's General Fund. Implementations of the outcomes of the discussion around a trial may have resource implications, which would need to be considered against Council's other priorities.

Risk Management

The recommendations of this report are not considered to present a potential risk to Council.

Options

The recommendations present the opportunity for the COSS Committee to provide feedback and be active in defining a robust way of assessing the effectiveness of and the resourcing of a potential COSS naming trial in the former Wyong LGA. **Recommended.**

That only Council officers define the detail of the assessment and operation of a potential COSS naming trial in the former Wyong LGA. **Not recommended since the COSS Committee's involvement and support of the process is important for the trial.**

That a trial proceed without any assessment criteria and data collection to assess its outcomes. **Not recommended as there will be no way to undertake an evidence-based assessment of a potential trial.**
