<p>SUBSTANCES PROHIBITED FROM BEING DISCHARGED TO THE SEWERAGE SYSTEM</p> <p>The following substances are prohibited from being discharged to the sewerage system:</p> <ul style="list-style-type: none"> • organochlorine weedicides, fungicides, pesticides, herbicides and substances of a similar nature and/or wastes arising from the preparation of these substances • organophosphorus pesticides and/or waste arising from the preparation of these substances • any substances liable to produce noxious or poisonous vapours in the sewerage system • organic solvents and mineral oil • any flammable or explosive substances • discharges from 'Bulk Fuel Depots' • chromate from cooling towers • natural or synthetic resins, plastic monomers, synthetic adhesives, rubber and plastic emulsions • rain, surface, seepage or subsoil water, unless specifically permitted • solid matter • any substance assessed as not suitable to be discharged to the sewerage system • waste liquids that contain pollutants at concentrations which inhibit the sewage treatment process – refer <i>National Wastewater Source Management Guideline, July 2008, WSAA</i> • any other substances listed in a relevant regulation.
