4. TERMS AND CONDITIONS

Central Coast Council is the Road Authority for all local and regional roads within the Central Coast local government area. This application is required for approval by the Road Authority and by signing this application form, the applicant agrees that:

1. Hoarding/scaffolding structures within the road reserve will not be installed prior to receiving a Hoarding and Scaffolding Approval from Central Coast Council approving the erection of specified structures and satisfying all pre-installation requirements of that approval.

2. The application must include all information necessary to allow appropriate assessment by Council. Further information may be requested by Council which may include a request for an impact assessment of the hoarding/scaffolding proposed on the local community including vehicle traffic and pedestrians and/or an amended traffic management strategy.

3. Fees are applicable for this application and are outlined in Council's fees and charges found on Council's website. **The applicant will have to pay Council's monthly operational fees in addition to the Hoarding and Scaffolding base rate application fee prior to a Hoarding and Scaffolding approval being issued.** Monthly operational fees are calculated based on the duration that the hoarding/scaffolding structures will be erected in accordance with Council's fees and charges.
4. The applicant is responsible for any additional costs that result from call-outs of Council staff to repair hazardous situations and/or to make a site safe as a result of works undertaken and structures erected.
5. The applicant will be liable if structures are not erected in accordance with Council's approval and Policy for Hoardings. Erection of structures in accordance with Council's approval and Policy is necessary to address issues that may impact on the property owner, Council and the general public.
