Upon payment of the current fee to purchase a niche in one of Central Coast Council's Cemeteries, an exclusive Burial Licence will be issued to the person nominated as the Holder.

This exclusive Burial Licence gives that person, or any other person they nominate, the right to be buried in that portion of land (niche) over which they are the registered owner of the exclusive Burial Licence.

Should the deceased be the Holder, then the Burial Licence becomes part of his or her estate, to be administered by his or her Executor. If there is no Executor, then the Next of Kin who is the "major beneficiary" may authorise the opening of the niche for the interment of the deceased.

The exclusive Burial Licence can be transferred or bequeathed to a family member or Executor while ever the niche is vacant.

This is not legally complete until any transfer is registered in Central Coast Council's Cemetery Register. It is necessary to supply relevant information such as a will, statutory declaration or evidence of identity to transfer the ownership of an allotment in a Memorial Garden.

The interment of ashes in the Memorial Garden or Niche Wall under Central Coast Council's control is subject to the provisions of the Cremations Act 1936 and amendments and/or regulations made there under and to the rules and regulations of Central Coast Council.

Placement of ornaments or other items in or around the Memorial Gardens or Wall is not permitted. Central Coast Council will remove and dispose of any unauthorised items during routine maintenance visits.

Removal or planting of any trees, shrubs, flowers etc in the Gardens is not permitted.

Placement of ashes and the supply and installation of wall or garden niches and plaques is the responsibility of Central Coast Council.

To ensure that the Lawn Cemetery and Memorial Gardens are maintained to a high standard, no ornaments, crosses, statues, icons, vases or other items may be permanently or temporarily placed onto the lawn or in the gardens. The planting of any flowers, shrubs, grass or trees at the grave site or elsewhere within the cemetery and gardens is not permitted.
