6. If there is insufficient space for all the information you are required to disclose, you must attach an appendix which is to be properly identified and signed by you.
7. If there are no pecuniary interests or other matters of the kind required to be disclosed under a heading in this form, the word **"NIL"** is to be placed in an appropriate space under that heading.
8. Once all sections of the form are complete, sign the form using your electronic signature (see **help guide** if required) and save to an accessible location on your computer. If the form doesn't automatically open, locate in Windows Explorer and open. Click the 'Submit' button at the bottom of the form and follow the prompts to email the form to the relevant Officer. A message will pop up confirming your form has been submitted.
