- 8. Once all sections of the form are complete, sign the form using your electronic signature (see **help guide** if required) and save to an accessible location on your computer. If the form doesn't automatically open, locate in Windows Explorer and open. Click the 'Submit' button at the bottom of the form and follow the prompts to email the form to the relevant Officer. A message will pop up confirming your form has been submitted.
