#### 1 Introduction

The chairperson welcomed the group and completed an Acknowledgement of Country.

Andrew Bayley, Acting Manager National Parks and Wildlife Service (NPWS) was welcomed to the meeting replacing Steve Atkins who was an apology for the meeting.

#### 3 Update on Property sale negotiations and COSS sub - committee request 2.20pm

Update provided by Chris Barrett, Commercial Property Manager. Chris advised he is new to the role.

Chis Barrett advised that Council has quarantine funding specifically intended for acquisition of conservation land, – the challenge is when these properties come up for sale Council has not been agile enough to acquire the properties –
Chair suggested this is a concern for COSS committee.

Chris Barrett advised Council is in a challenging environment with acquisition as the real estate climate is rapidly changing Due to legislative and other constraints.

Chair advised that Council's Environmental Management Unit can provide strategic advice on acquisitions but require the Property Section to assist with negotiation and acquisition of identified parcels.

• A Committee member asked if there still a freeze on COSS funds.

Response from Alice Howe – funds are held in restricted reserve for COSS lands.

Andrew Bayley of NPWS said it has been good working with Larry Melican and his team, inspections are happening this week and Wambina, Larry Melican will provide information as NPWS know the least about this area.

A Committee member enquired further about Wambina land that was going to come across to COSS and that Liz Phelps (NPWS) performed a ground truth years ago and wonders what the delay is. Andrew Bayley responded that NPWS will have a fresh look.

Two committee members who live locally offered to also inspect and advise if the main features are still there. Would appreciate a local to visit site with NPWS.

### 5 Update on Biodiversity Strategy and land acquisition and prioritisation (standing agenda item)

Update provided by Larry Melican, Section Manager Natural Assets and Biodiversity in Rochelle Lawson's absence. Presentation included the following key points:

- The dedication of land at 39 Dell Road, West Gosford to Council zoned C2 Environmental Conservation to Council for inclusion into the COSS (at no cost to Council) is being proposed as part of a Planning Proposal– Site details include:
  - approx. 7.3 hectares
  - The rehabilitation and maintenance of the site prior to Council taking control of the land

The chair asked the committee whether they endorse pursuing that 39 Dell Road as part of the COSS estate which the committee supported.

**Action:** That the COSS Advisory Group support for the dedication of the C2 Environmental Conservation Zoned land at 39 Dell Road, West Gosford, pending the determination of the Planning Proposal, be noted by Council.



Update provided by Larry Melican, Section Manager Natural Assets and Biodiversity. Presentation included the following key points:

- Focus is on production of volunteer program and restoration work.
- Volunteer group at nursery a huge success, started prior to covid, more meaningful work in the whole plant cycle from seed to planting in the environment.
- Interest from local school to bring group to Thursday volunteer session.
- More diverse volunteering opportunity has paid off. More enjoyable for volunteers great buzz
- Have funds to replace a greenhouse that will assist with production
- Reduced resources at nursery Were three dedicated staff, now services all Local Government Area with no dedicated staff, just volunteers.

Committee member praised the work Michael Smith, Team Leader Landcare, for his work at the nursery.

- Planning for next round of aerial baiting in NP areas, foxes, and wild dogs locally, Jilliby State Conservation Area, Brisbane Water and Popran National Parks begins October 2022.
- Spring Hazard reduction program planned, considerable rainfall and rain fronts keep topping up moisture delaying this, will conduct in a few weeks' time.
- On-site inspections coming up with Crackneck Point Lookout upgrade, Somersby Falls upgrade still to occur. Crackneck Point Lookout is first and hoping to complete by December 2022. Tenders and contracts being worked through.
- Since East Coast low, NPWS has been making insurance claims ranging from damage to fire trails to beach accesses, walking tracks some completed, however some are large engineering jobs.
- Beaches have lots of debris and EPA barge assisting with removal.
- NPWS involved in Varroa Mite eradication operation with DPI. Central Coast is in southern end of this, DPI may lease baiting sites on National Parks, may go on for years.

#### 8 Update from Community representatives (standing agenda item) 3.12pm

 Committee raised concerns regarding unauthorised clearing in Wambina with a recent email being sent to Larry Melican from one Committee member. Larry Melican advises that Compliance has been in touch with adjoining property owner and staff have inspected – it appears, a ride on mower has gone across from private land probably in last 4-6 weeks. More investigation to do.

Staff will bring an update on the unauthorised clearing in Wambina and Council land at next meeting.

- Gary Chestnut advised that the Community Environment Network is working with University of Newcastle and Central Coast Council about Love Trees, Love COSS on 17<sup>th</sup> September 2022 at Ourimbah Campus. There will be 30 different stalls from several community groups, speakers, and a photography exhibition. Event runs from 10am-3pm.
- Gary Chestnut reported that Landcare Australia had their regional conference recently which included a visit to Kincumba Mountain. Central Coast Council's Michael Smith, Team Leader Landcare gave a presentation which impressed the attending conference delegates.
- Gary Chestnut also gave a presentation at the Landcare event and noted during research, that Central Coast Council's website pages do not talk about COSS. Why doesn't Council have a more prominent communication on the website about COSS instead of Mountain bike riding. Committee member was shocked at the lack of information.

Larry Melican said the website is an issue and Environment Education officers have been working on the strategy, with an action to look at the website and bring up to date as it is lacking information in many areas – Committee member looks forward to this being resolved.

 Committee member asked for an update on the mountain biking issue at Kincumba Mountain stating that more information on prohibited mountain bike riding on COSS lands needs to be emphasised –

Larry Melican advised that a stakeholder group were to develop masterplan on areas suited on not suited to mountain bike riding. Challenge is resourcing to be able to develop that. Stakeholder group will need lots of resources and support.

Andrew Bayley also advised that the NPWS Plan of Management for Bouddi National Park - regarding mountain bike strategy was in development. NPWS is liaising with the mountain biking community.



- A Committee member enquired if a letter was received from the Minister from Action 144 Chair advised that this is now a completed action.
- A Committee member enquired on the need for the Deferred Matter lands to be advertised again.

Alice Howe responded that the LEP is on track to be publicly exhibited and advertised before Christmas 2022 with the completion date to be this financial year. It is a Gateway process and needs to be readvertised due to the previous round of deferred matters. As it wasn't supported by the Department of Planning, it is a new process with new mapping. Needs to be reexhibited due to new zones in LEP.


