1 Introduction

In regard to Item 8, Comparison between CEN COSS Report and Central Coast Biodiversity Strategy, Gary Chestnut declared a significant non-pecuniary interest as he submitted a Comparison report to the Unit Manager Environmental Management and is also a member of the CEN Executive. Gary is not a voting member on the Committee so was able to partake in discussion for this item.

2 Previous business

1.02pm

The group confirmed the minutes from the previous meeting as noted below, which were distributed to members via email and uploaded to Council's website, subject to the following changes:

21 September 2021 Coastal Open Space System Committee Meeting Minutes

- Removing specific people's names in comments made in General Business.
- Including comments regarding COSS land at Matcham as follows: Members of the community have inspected COSS land at Matcham which was alleged to have been subject to unauthorised clearing activities and are of the belief that it has impacted COSS land.

Action: Staff to investigate the unauthorised clearing activities at Matcham and report back to the next COSS meeting advising what action has been taken against the people who undertook the clearing.

The action log was reviewed with updates recorded (see page 10).

Recommendation: In regard to previous action 124, Council to send a follow up letter to the Minister advising of the significant community concerns regarding the clearing of land (public and private) and request that if the legislation isn't going to be changed, that regulatory control of deferred matters zoned land be given back to Council as opposed to DPIE and LLS.

Action 140 – Peter Sheath has been in contact with Gary Chestnut and an email with additional information was sent from Gary, awaiting a response. Staff to follow up with Peter Sheath.

3 Mountain Bike Feasibility Study Report

1.15pm

Sharyn Styman (Environmental Management and Projects Officer) provided an update on the Mountain Bike Feasibility Study Discussion Paper including the following:

- Supply analysis
- Community consultation
- Case studies



- Site selection criteria
- Feasibility analysis and conclusions

Public exhibition of the discussion paper and preparation of a report on the outcomes of the community consultation has been completed.

A video overview of the information presented in the discussion paper was available on YourVoiceOurCoast along with a guided submission form. The guided submission form focused on four areas:

- Views and attitudes
- Site selection criteria
- Management options
- Recommendations

John Andrews wished to express his concerns regarding Mountain Biking on the Central Coast as a COSS Committee member of more than 10 years. He believes it has been an ongoing issue and mountain bike riding is not compatible with COSS land and that people have the option to pay to do it on private land.

Recommendation: The Coastal Open Space System (COSS) Committee members would like to express to Council their rejection of any mountain biking trails being established in COSS land or being identified for inclusion in COSS land as part of the Central Coast Mountain Biking Plan which will be reported to Council at the Ordinary Meeting on 14 December 2021.

4	Update on Biodiversity Strategy (standing agenda item)	2.02pm

Rochelle Lawson (Senior Ecologist) provided an update on the Biodiversity Strategy including the following:

Action 1.2.1: Implement site management plans to rehabilitate degraded bushland and coastal ecosystems – the 21/22 program included 37 of our priority reserves covering almost 1400hectares and includes a program of bush regeneration works from Jilliby in the north to Rumbalara in the south.



The hollow bearing tree relocation funded by Local Land Services is likely to be completed this week.

5 Land acquisition and prioritisation (standing agenda item) 2.05pm

Rochelle Lawson (Senior Ecologist) provided an update on land acquisition and prioritisation.

The Land Acquisition program has effectively been on hold since the financial crisis. In 2021, there was a transfer of 7 parcels of Department of Planning, Industry and Environment (DPIE) land at Green Point and Erina to Council's ownership. Also, Council purchased a parcel that was added to a reserve in Tumbi Umbi (Eric Malouf Close). A Biodiversity Stewardship Agreement for two reserves (Bomaderry Cres R0345, Bundeena Road Reserve R0346) was completed in July 2021 and annual payments are expected to begin in 2022.

Action: A map of the Glenning Valley reserves and Biodiversity Stewardship Agreement Council Report to be distributed to Committee members.

The Committee discussed a property at 194 Matcham Road, Matcham, 15.4hectares of a treed ridgeline which adjoins to existing COSS lands and was sold 12 months ago for \$2.1Million. It was noted that this would have been an ideal parcel for COSS acquisition.


There was an action from the 21 September 2021 meeting as follows:

Staff to provide an update to the Committee on the sale of 71 Debenham Road.

Larry Melican provided the following update:

- The site is 5.66hectares and is a Deferred Matters Zone which was identified for COSS acquisition.
- The Valuer General had valued the land at \$606,000 on 1 September 2019.
- Council received a valuation on 29 July 2020 at \$340,000 with assessment that marketability was fair to poor.
- The property had been on the market since September 2019 for \$600,000.
- A letter of offer went to the owners on 6 August 2020 for \$340,000. No response was received.
- The property was sold on 5 July 2021 for \$500,000.

The Committee expressed concerns that Council didn't obtain a proper valuation of the land and there are considerable flaws in the land acquisition process that are resulting in valuable conservation land not being acquired. It was suggested that Section 149 requests (which do identify parcels considered



Action: Staff to follow up with the Economic and Property Development team and request that they meet with the COSS Sub-Committee to discuss property sale negotiations and the acquisition process, prior to presenting to the Committee in the new year.

Item 6 was brought forward ahead of item 4. Anu Vijayan attended for Item 6 and left at the conclusion of this item.

6 Journal of Environmental Management Paper 1.39pm

Anu Vijayan, Master of Research, Macquarie University provided the Committee with a presentation on the Journal of Environmental Management paper completed as part of a Master of Research project that Rochelle was Co-Supervisor of.

7 Land transfer Council to National Parks

2.35pm

Larry Melican (Section Manager Natural Assets and Biodiversity) provided the Committee with an overview of the chronology of events that was circulated to the Committee with the agenda on Potential Land Transfer to NPWS.

At the last meeting the Committee had expressed concerns that they weren't being kept informed of negotiations with National Parks with the lands to be transferred to National Parks estates.

There is a detailed process to work through in determining which parcels of land are suitable to be transferred to NPWS including making sure the land is up to a particular standard and if not whether there are actions that can be taken to improve the condition of it. The NPWS Reserve Establishment



Team have considered things like encumbrances that may be on the land, desktop analysis was completed however with the majority of parcels that were of interest, they were inspected on the ground and there is a plan in place for further inspections to be carried out in the new year.

The Committee expressed concerns regarding the lots that were left off the list proposed to the Minister, in particular a private lot at Bensville, which has National Parks on one side and Council reserves on the other side, and this lot remains a vital link between the North.

Recommendation: The Committee request that Council write to the Minister noting concerns about lots that were left off the list for potential land transfer to NPWS and request that further consideration be given to private land, not just public land. Furthermore, representations should be made to local members requesting support of this.

8	Comparison between CEN COSS Report and	2.43pm

There was an action from the 21 September 2021 meeting as follows:

The Comparison undertaken by CEN of the COSS Report of Council's Biodiversity Strategy to be circulated to Committee members. Unit Manager Environmental Management to investigate the option of an Extraordinary Meeting to discuss the report.

A decision was made to discuss the item at today's ordinary meeting rather than hold an extraordinary meeting for this item.

The majority of recommendations from the CEN COSS report and Council's response were noted and agreed upon, however the Committee discussed at length the matter of evaluating land suitable for consideration to expand the Coastal Open Space System into the former Wyong Shire Council Local Government Area. It was noted that in a meeting with Gary Chestnut and the Administrator, the Administrator had noted he was happy to be presented with a list of parcels of land that could be identified as COSS, provided it did not include any additional land that Council does not already manage.

Action: Staff to arrange a further meeting with Gary Chestnut with a view to identifying some existing natural assets and other conservation reserves in the former Wyong LGA that may be considered for trial under the COSS branding and to identify likely tasks required in order to proceed with such a project.



9 Update from external representatives (standing agenda item)

3.04pm

David Green – LLS

- LLS have had a meeting with Council staff regarding koalas on the Central Coast and song metres used to record the sound of male koalas. There was discussion around applying for funding through the environmental restoration fund on behalf of Council however LLS are not in a position to do that at this stage.
- LLS have applied for funding under the Environmental Trust for Grey Headed Flying Fox which focuses on the colony at North Avoca and also provides funding to automate the misting system at Wyoming.
- Currently working with Rochelle on a video for the hollow bearing tree relocation.
- Dog baiting project has been completed for the year.
- Staff recently captured 4 cane toads in a nursery at Kenthurst which were identified as coming down from Queensland.
- Currently liaising with Walk about Wildlife park regarding cultural burning. 2 other burns are planned for Baines Road, Mangrove Mountain in Autumn however they are highly dependent on the weather.
- Local Land Services office has moved from Wyong to Albany Street North in Gosford.

Andrew Baylee - NPWS

- There hasn't been much of a fire season this year which has allowed for prescribed burns during spring with 6 completed in the Central Coast LGA.
- A few cultural burns planned, one outside of the Central Coast LGA, another at Daley's Point in Bouddi National Park.
- Starting to get a lot of the volunteer programs back up and running that were paused due to Covid which involves work with risk planning and getting volunteers back into reserves for bush regeneration work.
- An aerial baiting program targeting wild dogs and foxes occurred throughout October in the Watagans, Jilliby State Conservation Area and for the first time included Brisbane Water National Park and Popran National Park.
- NPWS was part of a large capital program that the Government embarked upon to do with asset renewal in National Parks. Stage 3 of the Bouddi Coastal track has been completed and background work has commenced for Stage 4 to begin in the new year.
- Close to having the planning phase completed for Somersby Falls which involves renewal of amenities at the top of the falls, BBQ areas etc with work commencing early 2022.
- Crackneck lookout planning phase has also been completed which involved community consultation as well as discussion with Council's Disability Inclusion Officer to ensure access requirements were factored in.
- NPWS has been lucky to have a top of in funding to start targeting a lot of weed areas that have been identified as we haven't been able to do as much with volunteers due to Covid. Hopeful that this will be incorporated into normal works with field staff.

• NPWS has a cycling policy and strategy currently on public exhibition till end of January 2022. National Parks are also experiencing an uptake in mountain bike activities and illegal trail construction has continued.

10 General business

- a) The Committee discussed land at Wambina Rd, Matcham. Staff had attended the site to identify where the boundary of land is between public and private land. More recently with the assistance of compliance officers, the land owner had been contacted and requested to prepare a bush land management plan to be implemented at their cost to rehabilitate the site that has been impacted.
- b) The Committee expressed their extreme disappointment about the sale of land at Thompson Vale Road, Doyalson to pay off Council debt. The Committee had reinforced the conservation values of the land and on a number of occasions had expressed concerns and requested that it be removed from sale however it appears these concerns and comments have not been considered.
- c) The Committee discussed the recent intrusion into COSS land adjoining private parcels by private landowners/managers.
- d) The Committee discussed meeting location moving forward due to the sale of the Gosford Administration Building. Some Committee Members expressed their frustration that there will no longer be a meeting venue available on the southern end of the Central Coast for these Advisory Group meetings.

It was agreed that meetings would proceed in hybrid format with the Wyong Committee room being available to meet however members are more than welcome to continue to join via Microsoft Teams if that option is more convenient.

e) Luke Sulkowski advised of staffing changes in the new year. He will be moving across to Environmental Compliance and Systems Unit due to a resignation and Larry Melican will be acting in his role. David Milliken is currently acting as Director Environment and Planning.
