#### 1 Introduction

#### 3 Water supply system status report (standing item)

Satpal Singh (Senior Engineer Water Resource Planning) provided the group with a Water Supply System Update presentation including the following key topics:

Luke Drury (Section Manager Assets and Planning) provided the group with an update on the Central Coast Water Security Plan (CCWSP) which was reported to the 14 December 2021 Council meeting.

The CCWSP is a drinking water plan for our growing community. The CCWSP replaces WaterPlan 2050 as the region's water security plan and is a key element of Council's Integrated Water Cycle Management (IWCM) Plan that is being developed under the Department of Planning Industry and Environment (DPIE) IWCM regulatory framework.

Public exhibition commenced on 31 August 2021 for a period of 6 weeks via YourVoiceOurCoast website and included the plan, technical papers, fact sheets, video and FAQs as well as online Q&A sessions.

During the exhibition period there were over 1,300 visits to the Your Voice Our Coast project page and over 340 downloads of the plan. Staff maintained an online Q&A board and held three online sessions with interested groups. As a result, staff received 45 submissions through the online guided submission form and a further 10 submissions via email and post. After being endorsed at last night's Council meeting, the next step is to submit the plan to DPIE for their formal review and in-principal approval in the first quarter of 2022. This will assist plan implementation from mid-2022 while the broader IWCM activities are undertaken.

#### 5 Water resilience works projects (standing item) 3.39pm

Luke Drury (Section Manager Assets and Planning) provided the group with an update on Water resilience works projects.

- Mardi Water Treatment Plant
  - Tender evaluation in final stages
  - Early works ongoing for lagoon desludging
  - New sludge during beds constructed
  - Aiming for contract award early 2022
  - o Scheduled completion early 2024
- Mooney Dam WPS
  - Concept designs complete
  - o Detail design and construction phase business case on hold among other capital works priorities
- Leak Detection
  - o Sixth quarterly package of work completed. Rescanning of problem suburbs continuing in addition to new suburbs
  - Leakage rates in reticulation network sufficient to retain focus on those assets over the trunk main assets
  - Initial scan entire network expected by mid-2022
- Drought response desal readiness
  - Studies to support consent amendment for intake structure type and flexibility in scale to ensure plant is 'plan ready' if required as drought response
  - Final shortlisted sites for intake structure confirmed
  - Subsequent detailed studies to support consent amendment deferred to 22/23
- **Recycled Water Review and Refurb** 
  - o Water Resilience Committee agreed action to commence detailed water quality monitoring
  - o Upfront maintenance and three month water quality testing program commenced April 2021
  - o First phase results being reviewed ahead of quarterly sampling being undertaken in Sept/Dec/March
  - CCWSP actions to guide next steps



The Mangrove Creek Dam Rectification has been taken off the list as the project is complete, along with the Mardi to Warnervale Pipeline, which is fully operational with the official opening event being held today.

#### 6 Update on Water Business Review (Action 44) and IPART Pricing Review Update 3.50pm

Jamie Loader (Director Water and Sewer) provided the group with an update on the Water Business Review and IPART Pricing Review Update.

#### Water Business Review

Council engaged consultants KBR to undertake a review of the governance model for the Water and Sewer Business. The driver for this being the fact that Central Coast Council is the only Council in NSW that is regulated by IPART for pricing and there are a number of conflicts between the *Local Government Act* requirements, the *Water Management Act* requirements and the *IPART Act* with operational and strategic difficulties with the differing requirements.

KBR have considered several options including the following:

- Revisiting the Central Coast Water Corporation model that was previously created under the two former Councils.
- A variation of that which would be internal commercialisation.
- An option around selling assets which was not favoured but still needed to be investigated.
- Joint venture model where Council would work with another utility i.e. Hunter Water, with Council owning the assets and the other utility operating the assets.

The report has been completed by KBR and the CEO and Administrator have been briefed. All options are complex and would require legislative change and government intervention.

A number of meetings are currently taking place and further analysis including pros and cons and what the legislative pathway might be is required. A discussion paper is being prepared to go to the second February 2022 Council meeting. Council has also engaged further legal advice to assist.


#### IPART pricing review update

The submission went in September 2021 and the Public Hearing was held October 2021. Expenditure consultants undertook a review including interviewing staff. Council is now awaiting the consultants draft report which is expected the first week of February 2022. Staff will have until 21 February to respond to draft consultants report.

When the draft IPART Determination is released in March it will be based on the draft consultants report as they won't have time to consider our feedback for inclusion in the draft determination. Once the draft determination is released, Council will have a month to respond with the final determination being released in May.

Council has received positive feedback so far on the submission.
