1 Introduction 2.08pm

The chairperson welcomed the group and completed an Acknowledgement of Country.

#### 3 Water supply system status report (standing item)

2.10pm

Satpal Singh (Senior Engineer Water Resource Planning) provided the group with a Water Supply System Update presentation including:

- Dam storage levels
- Rainfall statistics
- River extractions
- Status of important assets
- Hunter Water Storage and Transfers
- Water Restrictions
- Water Demands
- Rainfall outlook July to September 2022
- Min/Max Temperature Outlook July to September 2022
- Climate driver update including La Nina
- Forecast for Ourimbah Creek streamflow September to June to August 2022

Question from a Committee member regarding Hunter and Central Coast climate synchronicity. Does this effect the joint modelling?

Advised in response that the modelling while based on historical records, also includes stochastic analysis to generate alternate patterns of rainfall/streamflow that considers overlapping drought between the two regions. The stochastic analysis preserves the mean and standard deviations of the historical record but generates over 1,000 alternate sets of data to account for climate variability. Updating the historical dataset continues to take place, the input of data guides the modelling outcomes.

Question regarding seepage rate at Mangrove Creek Dam - has there been an increase? Confirmation yes there has been, but only minor as the level in the dam rises. Staff are monitoring in accordance with a 'first fill' process from 76% onwards, additional inspection and monitoring is being undertaken. New seepage points have been discovered, but nothing considered as a concern.

General discussion regarding proactive and preventative maintenance and leak detection.

Overall shift in technology and faster turn around with analysing the data and information. Included discussion of satellite image analysis opportunities being reviewed.

#### - Mardi Water Treatment Plant

Council resolution to reject tenders and negotiate with a view to entering a contract Final IPART determination deemed the project as prudent with efficiency recommendations Stabilisation works to sludge lagoon underway Negotiation to follow efficiency and funding review

M2WP (Mardi to Warnervale Pipeline) Commissioning
 CCC and HWC Operational team bulk transfer commissioning
 35MLD flow achieved during the day, on multiple days
 Flow to HWC reduced overnight due to reduced demands
 Up to 40MLD max flow achieved for short periods

#### Mooney Dam WPS

Concepts designs complete

Detail Design and Construction phase business case program dependant on water fund capital program reprioritisation to fit MWTP

#### - Leak Detection

Eighth quarterly package of work completed. Rescanning suburbs. Wyoming and Green Point continued prioritisation. Initial scan entire network expected by mid-2022.

### - Drought response desal. readiness

Studies to support consent amendment for intake structure type and flexibility Final shortlisted sites for intake structure confirmed.

Subsequent detailed studies to support consent amendment deferred to late 22/23

Summary of IPART's key findings:

IPART has increased prices but not by as much as Council proposed

This will be the last time IPART set stormwater prices

Council must markedly improve its performance and be more accountable for its spending

- Total bills On an average 17% typical household 1 July 2022 then by 6%, 8% and 1% over the following three years
- Bills will remain relatively low
