Good Afternoon


Below are the questions raised today by Councillors on the Skype meeting today that require a response. Can you provide updates/response to Councillor Support with a cc to Gary and to me.

- JULIE – At the meeting you attended this week was the supply of PPE and cleaning supplies to not for profit organisations raised (Holstein)
- JULIE – There was mention previously of vandalism in some public toilets (soap/toilet paper etc). Does this continue to be an issue? (Holstein) (Matthews)

- **CRAIG** – Seeking list of the shovel ready projects for which we applied for funding that went to the State and Commonwealth (Smith)
- BORIS – Consider whether we give concession as to the limit on bulk pick ups as people do not have the ability to go to the tip (Sundstrom)
- SCOTT – Can we source the stages of approach from NSW Health in managing the response to COVID-19 – perhaps through LEMO (Sundstrom)
- SCOTT – Can we look at flexible arrangements to permit food trucks to operate at various locations (within NSW Health requirements) (Sundstrom)
- BORIS/JULIE – Is there capacity to make a car park available (with toilet facilities) for homeless people who might need access to facilities (Hogan)
- BORIS – Will Council be closing down the boat ramps (Pilon)
- JULIE – What are the calls to Customer Service about? What proportion is related to COVID-19? (Mehrtens)
- **CRAIG** – What is the anticipated impact of the current situation on Council’s investments? (MacGregor)
- JULIE – Can we get a list of cancelled or impacted leases? (Greenaway)
- KRYSTIE – What is the impact on Apprentices and Trainees given the current circumstances and given TAFE has closed (Hogan)
- **CRAIG** – If funds were unrestricted would approval to use those funds have to go to Council or would it be something Gary could do under delegation in consultation with Councillors (Smith)
