- This application and application fee is to investigate matters relating to the road, undertake consultation with key stakeholders in order to determine whether it can be sold, and if approved, advise on the process of sale.
- Please note that processing of this application may take up to three (3) months.

A minimum fee will be charged at the time of lodgement of the application. Additional fees will be charged, before the determination of the application, and upon completion of the sale. All fees will be calculated with Council's Fee and Charges.

- Under the Roads Act 1993 the sale of any land will need to undergo a community consultation process. Should other adjoining property owners with an interest in the land be identified during this process, the sale may proceed to a competitive sale process.
- Should the closure not proceed any fees paid will NOT be refunded
- That all professionals costs such as surveyors, legal and valuers will be payable by the applicant
- The applicant agrees to consolidate the lot with adjoining lot at the end of the closure process.
