Capital Works:

Roads

\$1.5M Warnervale Road (Over Culvert): Road Upgrade is being funded from LIRS funding received in the 2012/13 financial year and therefore needs to be removed from the SRV funded projects. As there is additional \$1.5M SRV funding available in 2013/14 the following projects have been brought forward:

a.	Anita Avenue, cnr of Agatha in Lake Munmorah (road upgrade including stormwater drainage)		\$550,000
b.	Maitland Street in Norah Head (road upgrade including stormwater drainage)		\$400,000
C.	Bunning Creek Road in Yarramalong (road seal upgrade)	Total:	\$550,000 \$1,500,000

In the *Capital Works Program 2013-17* all total budgets have been adjusted to allow for the \$1.5M adjustment in closing the gap projects across options 2 (9.5% SRV) and 3 (6.9% SRV). Tables will be adjusted for the public exhibition copy to reflect the revised budgets.

Removal of projects with no amounts shown in any of the three options within the Roads principal activity as these projects are being brought forward into the 2012/13 financial year. Details will be discussed as part of the Q2 reporting.
