NSW Electricity Industry

The following comments are offered in response to particular criteria that the Committee is required to examine in its statement on the impacts of the proposed changes to the State Electricity Industry.

The Direct and Indirect Social Usefulness of a Public Asset, Service or Utility

Issues that warrant consideration are:

- Profits earned by publically owned / operated utilities are retained in public hands. The private sector will only become involved if it can earn a profit. Unless this profit can be paid for by efficiency improvements then it must be met by higher charges and / or reduced levels of service. The Owen Report indicates that the National Electricity Market (NEM) is efficient. Lower charges and / or higher levels of service arising from public ownership / operation are considered to be benefits that should not be discarded lightly.
- * Publically owned / operated utilities do not require a high level of regulation to ensure compliance with service delivery, environmental and social standards. A privately owned / leased utility will require a significantly higher level of regulation. The additional cost of this regulation will need to be met by increased charges / taxes.
- * A publically owned / operated utility has significant flexibility to respond to changing circumstances such as environmental standards, climate change, service standards, global warming etc. Governments can enact relevant changes in public utilities without incurring cost penalties associated with private sector contracts.

The Retention Value of the Enterprise Measured Against its Sale Value

Based on the NSW Government's response to the Owen Inquiry Report it is assumed that Sale Value should be Lease Value.

Any calculation to the true lease value to the community needs to take into account the following additional costs associated with involvement of the private sector;

- * the profits that will flow to the private sector
- * the cost of administering the lease
- * the increased cost of regulation

As indicated above, unless these additional costs are recovered by efficiency gains, which would be contrary to the findings of the Owen Inquiry then any commercial calculation of nett value to the community will be negative.

The Current Structure of the Market Place

While the electricity market can theoretically be defined as competitive the same can also be said of the petrol market and the food market. Recent developments would seem to indicate that it would be in the communities interest if the Government could exert some control over these industries.

The Government, as a competitor in the electricity industry, can exert more control than it could as a regulator and without incurring the significant cost of regulation.

This raises the issue of why the whole generation industry needs to be leased to achieve the key objective of the Owen Inquiry which is to encourage the private sector to fund the estimated \$15 billion investment required over the next 10-15 years. This could be achieved by the private sector only providing the additional generating capacity when it is required. This approach may achieve the best of both worlds.

The Impact on Specific Groups or Regional Areas

With two power stations located within the Wyong Shire, the electricity industry is a large employer within an area that is relatively disadvantaged socially and economically. Further unemployment would have unacceptable impacts on the Shire.

These two power stations (Vales Point and Munmorah) draw and discharge cooling water from / to the local lakes systems. As such their potential for environmental impact is significant. As a public utility Delta Electricity has worked with the Councils (Wyong and Lake Macquarie) to minimise this impact. Can this level of co-operation be expected from a private operator?

The Impact on Employment, Skills, Training etc

Within Australia there is a widely recognised skills shortage. While this cannot be attributed to any single reason there is a strong link, in particular industries, between moves away from public utilities to more privatised structures and a reduction in skills development. An example of this is the reduction in water and sewerage engineer / technicians as a result of the corporatisation of Sydney Water and Hunter Water. Neither of these organisations now support the training and development programmes which were pursued before corporatisation. It is suggested that the transition from State owned Corporation to privately owned / lease facility will further compound this problem within the electricity industry.

Long Term as Well as Short to Medium term Considerations

Leasing the States Generating capacity may, in the short term, negate the need for the State to raise an estimated \$15 billion for capital investment over the next 10-15 years.

In the medium to long term electricity consumers in NSW will pay:

- * the additional cost of administering these leases
- * the additional cost of regulating private sector operators
- * the additional cost of the profits the private sector will seek in entering into these leases

The Government, in entering into these long term leases will also expose itself to the following risks;

- * contractual risks the private sector will not enter into these leases unless the return is virtually guaranteed. Any changes to the leases which the Government wishes to make in the future as a result of changing circumstances such as climate change / global warming will incur cost penalties.
- * cost of regulation risks how much will it actually cost to ensure the electricity market remains competitive if there are only private sector operator?

Dear Mr Welham

I thank Councillors from Wyong Shire Council for their interest in the Electricity Reform Agenda proposed by the NSW Government.

This is a very complex issue requiring a full understanding of how the industry currently operates including:

- how the National Electricity Market impacts (or will impact) on government owned power stations;
- the impact on the price of electricity of not providing additional generation capacity as well as the impact of any new carbon tax regime;
- the implications on the total State budget of sourcing the required funds to provide necessary upgrades and construction of new and existing power stations, whilst balancing funding for other essential areas such as Health, Education, Roads etc.; and
- how employment and conditions for workers in the industry can be protected now and into the future.

Over the past few months I have been researching all of these issues in detail, so that I have a full understanding of the impact on the community of either carrying out these proposals or the implications of maintaining the status quo.

This research has included visits to meetings of union members at Vales Point and Eraring Power Stations and a detailed briefing and tour of Delta facilities. This has involved gaining an understanding of future infrastructure needs to ensure a stable supply of electricity for the business sector and community in NSW.

I have also met and talked to a number of people in the community who have exhibited a variety of views on the subject.

It is clear that the community generally has strong opinions against the current proposal and I will certainly ensure these views are made known to the Premier and Treasurer when Parliament resumes at the end of the month.

I also believe that there are number of areas, which requires further investigation, and consultation with the community.

The Central Coast community was built on the back of the power industry and you can be assured that I will work hard to ensure the best interests of all members of the public are looked after.

I would also like to point out that the Liberal Opposition had a policy of selling the retail electricity business sector going into the last election and there is no doubt that they would do the same with generation as Kennett did in Victoria with no protections for the work force and no plan for new generation.

The Greens have a policy of closing all coal fire power stations, which would effectively end the power industry and result in a major impact on jobs on the Central Coast and Lake Macquarie.

The NSW Government is investing \$2.9 billion upgrading electricity infrastructure in NSW including \$23 million at Berkley Vale to support the growth in local industry and jobs.

How we will provide the necessary energy supplies to meet the needs of a growing population and new industry is the biggest challenge this current Government faces.

I am committed to ensuring the growth of this region is supported by necessary infrastructure including electricity. The question is how this is best achieved for the benefit for all concerned.

Now Mr lemma and Mr Costa have made clear their intention to proceed with privatisation.



The Premier has received your representations dated 20 December 2007, on behalf of several of your constituents, about the recently announced changes to the NSW electricity sector, and has asked me to reply to you on his behalf.

The NSW electricity supply needs to keep up with the energy requirements of families and businesses across the State. NSW needs new baseload electricity generation built by about 2014.

To secure NSW's future energy needs at no cost to taxpayers, the NSW Government has accepted the key recommendation of the Owen Inquiry into Electricity Supply in NSW to restructure ownership arrangements for its electricity generation and retail businesses.

The restructure will involve the transfer of the Government's retail electricity functions to the private sector, and the lease of NSW power stations, with the exception of Snowy Hydro.

All current electricity infrastructure **assets will remain in public ownership**. That includes the power stations and the transmission and distribution 'poles and wires' of the State-owned companies EnergyAustralia, Integral Energy and Country Energy, as well as TransGrid.

The reforms will create the right conditions and incentives for the private sector to invest in baseload generation in New South Wales, saving taxpayers up to \$15 billion and unlocking funds for investment in roads, trains, hospitals, schools and other essential infrastructure.

The changes will also mean that people working in the electricity sector have a strong and secure employment future. All current public sector retail and generation workers are guaranteed jobs in their current locations across the State.

You may be assured that electricity customers (households and small businesses) will continue to be **protected by regulated retail prices** set by the Independent Pricing and Regulatory Tribunal, to at least 2013 or until the Government is satisfied there is sufficient competition in the retail energy market. The Government will also maintain its strong customer protection regulations and its social programs, including pensioner concessions.

The Government has also announced an environmental protection package including a new Energy Efficiency Strategy and additional funds for a \$100 million Renewable Energy Development Fund, to ensure the State remains in a strong position to tackle the ongoing challenges of climate change.

The Premier has received your correspondence about the recently announced changes to the NSW electricity sector, and has asked me to reply to you on his behalf.

The NSW electricity supply needs to keep up with the energy requirements of families and businesses across the State. NSW needs new baseload electricity generation built by about 2014.

To secure NSW's future energy needs at no cost to taxpayers, the NSW Government has accepted the key recommendation of the Owen Inquiry into Electricity Supply in NSW to restructure ownership arrangements for its electricity generation and retail businesses.

The restructure will involve the transfer of the Government's retail electricity functions to the private sector, and the lease of NSW power stations, with the exception of Snowy Hydro.

All current electricity infrastructure **assets will remain in public ownership**. That includes the power stations and the transmission and distribution 'poles and wires' of the State-owned companies EnergyAustralia, Integral Energy and Country Energy, as well as TransGrid.

The reforms will create the right conditions and incentives for the private sector to invest in baseload generation in New South Wales, saving taxpayers up to \$15 billion and unlocking funds for investment in roads, trains, hospitals, schools and other essential infrastructure.

The changes will also mean that people working in the electricity sector have a strong and secure employment future. All current public sector retail and generation workers are guaranteed jobs in their current locations across the State.
