CCROC AT GOSFORD CITY COUNCIL – 7 NOVEMBER 07 CENTRAL COAST ROADS – RTA UPDATE

Wyong

 Pacific Highway, Tuggerah Straight – Stage 1 - Anzac Rd to Mildon Rd – Nace Civil Engineering – Footway work, structural work for bridges over Mardi Creek almost completed / pavt surface widened to the west / traffic switch to the west shortly. Work scheduled to continue into 2nd qtr of 2008.

Stage 2 - Mildon to Johnson Rd – Tenders invited 29/10/07. Culvert widening piling completed to allow utilities to proceed on this section.

Pacific Highway Ourimbah

Stage 1 – Dog Trap Rd – Charles Street service road complete / traffic speed camera soon to be operational. Some fencing outstanding at RSL club.

Stage 2 from Glen Rd to Burns Rd – Tenders invited 29/10/07. Clearing, utility relocations and widening of Dog Trap Gully to precede the main contract.

 Pacific Highway Wyong Township – Continuing to assess alternative options put to us by Council and the community. Business impact & heritage investigations complete. Traffic studies ongoing.

Gosford

- Central Coast Highway (The Entrance Rd) Terrigal to Carlton Rd. GCC contracted to landscape.
- Central Coast Highway (The Entrance Rd) Ocean View Drive to Tumbi Rd. Stage 1 Pitt Rd to Tumbi Rd –retaining wall almost completed. This section scheduled for completion late 2007.

Stage 2 Ocean View Dr to Pitt Rd – Seymour Whyte P/L started in March 2007. Works are slightly ahead of schedule. Northbound pavement complete south of Reads Rd. Works will continue well into 2008.

- Central Coast Highway (The Entrance Road) Carlton Rd to Ocean View Drive. Stage 1 Carlton Road to Matcham Road - Connell Wagner engaged to design, and environmentally assessment and contract documentation Stage 2 Matcham Road to Ocean View Drive – have invited tenders to design, and environmentally assessment and contract documentation
- Central Coast Highway Dane Dr/Masons Pd upgrade alternative option developed for community information together with the environmental assessment.
- Avoca Drive The Entrance Rd to Sun Valley Rd. Works progressing well with median work next and some transition pavement over crest. Scheduled to complete in 2007.
- Avoca Drive Sun Valley to Bayside alternative option developed next to be released for community information together with the environmental assessment.

6. Occupational Health and Safety Issues and SIMCs - OHS	
RTA reported on its implementation of OHS desk top audits of SIMC councils. In a recent audit of Northern Region councils, a number of councils did not meet requirements. RTA stressed the importance of work place safety and is keen to work in partnership to help councils get up to standard. This includes training assistance and partnering between councils.	
RTA will continue to develop its OHS partnership with SIMC councils.	
LGSA indicated support for the initiative.	
7. HML Route Assessment Guidelines for Councils – CFS	RTA to
Philip Halton and Gavin Hill attended for this item.	distribute
RTA presented on in the implementation of HML vehicles supported by GPS Tracking enforcement.	Information Package on HML route assessment.
An information package to assist in route assessment for HML vehicles will be distributed to all councils shortly. RTA has presented to Regional consultative groups on the issue. Routes will require a council engineering sign off in most cases. RTA will maintain a register of all routes.	
LGSA noted that residents may be impacted as access approvals relate to routes but do not limit truck numbers. Councils will need to take this into account when considering route applications.	
It was noted that introduction of B triples and quad axle vehicles as restricted access vehicles was on the COAG agenda.	
There was discussion on the HML status of the New England Highway.	
8. Mobility Parking Scheme – DVS	
Irene Siu and Chelsea Hampel attended for this item.	
RTA reported on recent successful enforcement operations undertaken jointly with police and council parking officers from Sydney City and North Sydney Councils. Results are being reviewed and standardisation of data collection and operational agreements are being looked at.	RTA to liaise with LGSA re item in the Weekly Notice
RTA sought advice of other councils interested in joining in operations.	
It was agreed that LGSA put an item in the weekly notice.	
9. Release of Local Government Traffic Committee Guidelines and Implementation Strategy - TB	RTA to release guidelines.
Phil Margison attended for this item.	
RTA advised that after extensive consultation, the guidelines will be released in December and be available via the web. The guidelines clarify the delegations and the process to be followed by committees.	
RTA staff will be trained in early 2007 and RTA will undertake an audit in late 2007 to review the operation of guidelines.	
RTA confirmed there are no changes to the delegations, but the process guidelines will potentially affect the way some committees operate.	
10. Council Clustering – IM	RTA to make available a copy of responses.
RTA reported on the clustering process. Comments on the discussion paper have been received. Responses to the issues will be discussed at the next working party meeting in December. A copy of the responses will be available for inclusion in the weekly notice.	

RTA Local Government Liaison Committee – Minutes of Meeting held 14 April 2004 II. Local Government Road Safety Program - Update - RS RTA reported that the program is in consolidation mode with 81 officers over 91 councils. Efforts are focussing on efficiencies to avoid duplication, localise content, and provide generic material that can be adapted to local situations, and spread use of successful local innovations. The January 2007 Local Government Road Safety Conference is part of the ongoing commitment to the education of Road Safety Officers. 12. Road Safety Progress Report - RS RTA gave an update on the road toll and trends in key areas including reduction in pedestrian fatalities associated with 50K USL and increases in both male fatalities, and fatalities on the Newell Highway. There was discussion on Pacific Highway accidents, driver education, and numbers of injuries compared with fatalities. 13. Roads Act Review and Roads (General) Regulation Review - Update - IM Roads Act issues are still being worked through within the RTA. A briefing is being prepared for Parliamentary Counsel on the Roads (General) Regulation. A Regulatory Impact Statement is also being prepared for public comment. 14. Review of Road Classification -- IM RTA advised that the independent Panel has completed its report. LGSA expressed concern that the interim report favoured the RTA. Some councils are feeling that they will be impacted. LGSA also raised the issue of compensation, which was provided in last review. RTA is looking at the implications of what the Panel has proposed including the revenue neutral intention of the review. 14. Local Government Report LGSA advised of resolutions passed at the recent LGA conference. LGSA will write to the Minister shortly with details of these motions and seek his response. 15. General Business The following issues were raised by LGSA and discussed: Car Sharing - RTA advised that the draft discussion paper has been discussed with the Minister and its release is expected in December RTA landscaping policy in relation to planting native species RTA to provide Proposed bus lanes on Victoria Road and bus/bike lanes on Spit Bridge -- RTA to bus/bike lane detail to LGSA provide details to LGSA LGSA to provide Pedestrian activated traffic signals heavy vehicle Regulation of Heavy vehicles in relation to floating of major equipment such as issue detail to scrapers.
