1.1 Disclosure of Interest

1.3 Update from Interim Chief Executive Officer

At the request of the Mayor, the Interim Chief Executive Officer gave a brief overview of Council's current position in relation to the Mangrove Mountain landfill.

1.4 Terms of Reference for the Committee

There was discussion held regarding the Voting provisions in the Terms of Reference. The Committee recommends to include the following in the Terms of Reference:

Where consensus cannot be reached a vote may be taken at the request of the Chair. The minutes would reflect this process.

There was discussion held regarding the Quorum for the Committee. The Committee recommends that a Quorum for a Committee Meeting would be three Councillors and six voting community members and that the Terms of Reference be amended to reflect this.

There was discussion held regarding the Meeting Frequency provisions in the Terms of Reference. The Chairperson has exercised her authority to call additional meetings where required, this being monthly for the first three months. After three months, the Committee will reconsider the Meeting Frequency provisions.

There was discussion held regarding the Membership provisions in the Terms of Reference. The Committee recommends that the heading "External Agencies" be amended to "Non-Member Invitees" as well as the addition of a sub-heading Non-Voting Members which includes Staff and Non-Member Invitees.

Action: The revised draft Terms of Reference, including the Committee's recommendations, be reported to Council for consideration as soon as practicable.
