Briefing held at Applicant's request, commenced at 12.04pm

The Chair advised that the purpose of the briefing was for the applicant's representatives to provide details which they considered to be of a sensitive and/or commercial in confidence nature, that would not be appropriate to be discussed at the public meeting, and that other matters should be held over for the public meeting.

Lin Armstrong spoke about Stevens Group history in relation to the site.

Comments and information detailed regarding floor space on the site, and investigations regarding traffic issues by RMS and private developers.

Stevens Group believes it has demonstrated a number of times the left in/left out intersection works, and Lin Armstrong referenced a confidential report by GHD for Hunter and Central Coast Regional Development Corporation.

In relation to the current application, there have been many iterations of the proposal. This proposal has 60% of its traffic from users who are already on the road network as it stands, and the proponent contends has no impact on the highway, only the left-in access.

John Stevens has been the land owner for approximately 8 months, following settlement, and the land is vacant. Stevens Group believes the RMS has no intention to upgrade the Highway or undertake any work, including alternate links.

The land has been tendered by the Government on the premise that it would be suitable for development.
