#### Q84/18 **Speakers Policy Councillor Jillian Hogan**

### Response - Shane Sullivan, Acting Executive Manager Governance

The policy on the number of speakers at Council Meetings is in the Code of Meeting Practice and we have a future report coming to the next Council meeting with some proposed changes, so that will be an opportunity to look at the number of speakers for items. I can advise that when there are a lot of speakers we do go back to the speakers and ask if they can consider reducing the number of speakers of identifying a spokesperson.

# Q85/18 De-amalgamation of Central Coast Council Councillor Jillian Hogan

What is the process for de-amalgamation of Central Coast Council and are costings for the process available to Councillors or Community Members?

### Response - Brian Glendenning, Acting Chief Executive Officer

I can answer that question generally and you can tell me if you want a more detailed answer. There is no easy statutory process for de-amalgamation like there is for amalgamation. The Act treats those two processes differently, but you can pass a resolution which requests the Minister to consider de-amalgamating. You need to be quite specific, it needs to be precise and then you initiate the statutory process. If that is something that the Councillors wished to deal with, I would suggest that would need to be the subject of a specific Notice of Motion so that I can give the advice that you need as to how you would seek that.
